2. If your space assignment, vehicle pass and Street Fair information is not received by June 15th, notify the Americana Festival office at (937) 433-5898.
3. One (1) vehicle pass is issued for each Street Fair application and will only admit one (1) vehicle to the Street Fair area.
4. A vendor set-up may NOT extend beyond the ten (10') foot depth allowance to accommodate public safety. Street Fair personnel will monitor this policy.
5. The sidewalk behind vendor exhibits must be kept clear during the Street Fair for Police and Fire personnel emergency access.
